

# ACYC : THE NEW MEMBERSHIP OPTIONS

## **CORPORATE LIFE MEMBERSHIP – 150,000 Baht + VAT** (Valid on payment)

*(This membership option will be withdrawn once sufficient investment funds have been raised)*

### Benefits

- 1 principal member with 4 votes
- 3 non-voting memberships (restricted to company members)
- Run of the club facilities / participate in prize draws etc
- Members' discounts / special prices
- Company logo (or name if an individual) displayed on designated wall in club
- Company banner & link on all club website pages
- Banner ad in club newsletter (if such exists)
- First option to sponsor club events or any other club sponsorship opportunity
- Preferential advertising placements

**NOTE:** Should a company owner sell his/her business, the corporate life membership may be transferred with the company to the new owners or converted by the member to an Individual Life Membership. If transferred with the company, the original company owner will need to take out separate membership to remain an ACYC member.

## **INDIVIDUAL LIFE MEMBERSHIP – 150,000 Baht** (Valid on payment)

### Benefits

- 1 principal member with 4 votes

**NOTE:** Individual Life Membership is transferable to a family member on the death of the Life Member. The transferee must be a family member and must be nominated to the committee in writing in advance by the Individual Life Member. Such nomination may be amended at any time during the life of the member.

## **DEFINITION OF FAMILY**

## **CLUB PREMISES – THE LEASE**
